# FREE Online Course for Scratch During Summer 2019—Learn the for the 1st Time or Update Skills for Version 3.0

The University of Northern Iowa's Department of Computer Science is again offering an online summer course <u>Intro to</u> <u>Programming with Scratch</u>. The course is intended for teachers of all disciplines K-12 who want to learn how to program with Scratch and consider ways to incorporate Scratch into their classroom.

The online course will run June 10- July 20, 2019, and can be completed as an audit for free or received graduate credit for \$100.

The course will utilize the new 3.0 version of <u>Scratch</u>, which was released the first of the year. If you have used Scratch in the past and want to check out the updates in the new version, or if you would like to try Scratch for the first time, this is a great opportunity.

<u>Scratch (scratch.mit.edu)</u> is a free, online, graphical programming language/learning environment that allows students to learn about computer programming and computational thinking without worrying about complicated syntax. It was created by the Lifelong Kindergarten Lab at the MIT Media Lab and is designed for students aged 8-18 but is used by programmers of a variety of age and experience levels.

This course is appropriate for teachers of all disciplines who teach 3-12th grade. Participants will learn how to use Scratch for interactive art, animated storytelling, and game development. Previous programming experience is not a requirement for this course.

# CTE Perkins Intent to Apply & State VoEd Application for 2019-2020 Funding Now Open—Check the Boxes for \$\$\$\$\$

The Office of Public Instruction has again this year combined both the Federal Carl D. Perkins '*Intent to Apply*' AND the State CTE/VoEd Funding application for school districts' convenience. You can apply for one or both funding programs using this one electronic form.

The online link to access and complete the combined Federal and State Funding application is now available and listed below. It is also available on the CTE web page of the OPI website inside the *Funding* tab under *Carl D. Perkins*.

Authorized Representatives of Local Education Agencies (LEAs) will use the online link to access and complete the brief electronic form for the 2019-2020 E-Grants cycle. All public high schools and K-12 districts with qualifying Career and Technical Education (CTE) programs are eligible to apply for funding. Elementary districts are not eligible for Perkins or State CTE/VoEd monies.

**Districts will NOT receive a 2019-2020 Perkins allocation unless this electronic form is completed and submitted online** at the OPI on or before the deadline. These designations are binding and cannot be changed once allocations have been downloaded into the E-Grants system.

# 2018-2019 CTE Spring Data Collection—Time to Identify CTE Concentrators for Perkins Funding

The Career and Technical Education (CTE) Spring Data Collection begins March 1, 2019 and ends April 30, 2019. This AIM collection asks schools to identify all 12th grade high school students who were enrolled at any point during the current 2018-2019 school year who meet the definition of a CTE Concentrator.

CTE Concentrators are 12th graders who have earned three (3) or more credits in any CTE program in any combination during their years of high school. Currently, enrolled CTE courses count towards credits earned. CTE Concentrators must have the `CTE Concentrator' box checked and an `Area of Concentration' entered into the AIM/Infinite Campus data system.

If the student has a child or shares the parenting of a child, the `Single Parent' box should also be marked. High schools who receive funding from the Carl D. Perkins federal grant program must complete this CTE Spring Data Collection.

# Perkins V/Career and Technical Education Stakeholder Survey for New Montana Perkins State Plan

The Montana Office of the Commissioner of Higher Education and the Office of Public Instruction are seeking feedback and input from Montana's Perkins and Career & Technical Education stakeholders as the process for developing the new Montana State Plan for Career and Technical Education begins

On July 31, 2018, the President signed the *Strengthening Career and Technical Education for the 21st Century Act* into law. This bill reauthorizes the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins) and is referred to as Perkins V. This bipartisan measure reauthorizes the Carl D. Perkins Career and Technical Education Act, which provides roughly \$1.3 billion annually in Federal funding, administered by the U.S. Department of Education, for career and technical education (CTE) for our nation's youth and adults.

With the passage of Perkins V, all states, including Montana, must now develop a multi-year plan to guide and implement Perkins V. The Perkins V/Career and Technical Education Stakeholder Survey seeks to gather feedback, ideas, and input from Montana's Perkins and Career & Technical Education stakeholders—including CTE teachers, students, school/district administrators, counselors, and parents.

#### Computer Science Professional Development Opportunity at MSU-Bozeman – Funding Available for Teachers

Montana State University (MSU) will offer a Master of Science in Science Education (MSSE) course for Montana teachers, "Computer Science in the Classroom: Joy and Beauty of Data," July 21-26, 2019 on MSU's campus in Bozeman.

The 2-credit course is intended for 7-12th grade teachers who want to learn how to incorporate computational ideas in the classroom. In addition, teachers who take the course will be introduced to the broad area of data science and will extend their knowledge of the Python programming language. High school teachers who complete the course can potentially teach CSCI 127, The Joy and Beauty of Data, as a dual enrollment course.

The course builds upon the pre-requisite course, "Joy and Beauty of Computing," previously offered at MSU (2014-2017), the University of Montana (2017) and Montana Tech (2018). The course will be offered this summer at Salish Kootenai College in Pablo, Montana, June 24-28, 2019.

The Joy and Beauty of Data, CSCI 582, will be taught by Dr. John Paxton, Director, Gianforte School of Computing, Montana State University.

# **Fun Facts and Trivia**

The nickname of South Africa's Cape Town is the Mother City due to a 1930's local Cape Town newspaper claiming Cape Town was the only city in South Africa that could justly call itself a metropolis; the public took to this description and because the word metropolis is taken from the Greek derivative of meter or metros meaning mother and polis meaning city, the nickname of "Mother City" was born.

Table Mountain is over 6100 feet high and it is estimated that every month at least two couples get engaged on top of Table Mountain.

The Cape of Good Hope is a rocky headland on the Atlantic coast of the Cape Peninsula in Cape Town, South Africa.

The Cape of Good Hope used to be called the Cape of Storms as a result from the waves and storms causing the explorer Bartholomeu Dias to name the peninsula 'Cape of Storms' in 1488.

Later the Portuguese king changed the name to 'Cape of Good Hope' to make clear to other colonial powers that as from this point they were close to the sea route to India.

Back in the days the Castle of Good Hope used to be on the coast line, hence the name 'Strand Street' ('strand' means 'beach' in Dutch and Afrikaans); however, land reclamation to create Foreshore and the current harbor caused the coastline to move to the west.

Afrikaans is the most spoken language in the Western Cape; even though it's one of the youngest languages in the world it is the most spoken language in the Western Cap with Xhosa and English are the second and third language.

Afrikaans is a language of southern Africa, derived from the form of Dutch brought to the Cape by Protestant settlers in the 17th century, and an official language of South Africa.

Afrikaans is also known as Cape Dutch.

The world's first heart transplant took place in Cape Town in 1967 when the South African doctor Christiaan Barnard performed the world's first heart transplant; unfortunately, the patient died of pneumonia 18 days after the 'successful' transplant.

Cape Town is sometimes called the 'Tavern of the Seas;' mainly, because the port of Cape Town is deemed to be one of the busiest shipping corridors in the world.

Zeitz MOCAA-Museum of Contemporary Art Africa is the largest art museum in Africa and is also the world's largest museum as it covers nearly 20,000 square feet over nine floors with 100 gallery spaces showcasing the African Art and its diaspora.

Cape Town is blessed with the most number of Blue Flag Beaches in South Africa as issued by the Foundation for Environmental Education (FEE), which issues the certificates to the beaches and marine settings across Europe, Africa, Oceania, North America, South America, and Asia.

Robben Island is a small island in Table Bay, about 40 feet off the coast of Cape Town and is most known for its political prisoners, even Nelson Mandela was incarcerated here for 27 years.

Robben Island was also used to house leprosy patients, along with the mentally and chronically ill; however, after the Leprosy Repression Act was passed in 1892, the movement of lepers was restricted.

During World War II, Robben Island was used as a training and defense station by the British.

The African Penguin, also known as the Jackass Penguin and Black-footed Penguin is only found on the south-western coast of Africa.

The Cape Town Cycle Tour, an annual cycle race, usually 68 miles long, is the world's largest individually timed cycle race; with as many as 35,000 cyclists taking part.

Cool Runnings Toboggan Family Park is the only toboggan track in Africa; however, the toboggans don't run on the traditional snow and ice, instead, they run on a stainless-steel track.

The movie *Cool Runnings* was loosely based on the unlikely true story of the Jamaican bobsled team that participated in the 1988 Winter Olympics held in Calgary.

Cool Runnings earned more than \$68 million in the United States alone, and grossed over \$154.8 million worldwide.

Cool Runnings was the last movie that John Candy completed before he sadly passed away as he was still making Wagons East when he died, but that movie was not finished before his passing.

Nelson Christian Stokes, who earned his bachelor's degree in finance from the College of Business and Economics in 1987 from the University of Idaho, was a member of the famed 1998 Jamaican bobsled team. *Go Vandals!* 

Stokes, who served as the brakeman for the Jamaican team in both the 1998 and 1992 Winter Olympic Games, was a sprinter for the Vandal track and field team.

Sam Michener, member of the 2018 Olympic US bobsled team, graduated with his bachelor's degree in exercise science from the University of Idaho's College of Education, Health and Human Sciences in 2012. *Go Vandals Go!*
