They are all via Zoom and you do not need to register beforehand. There are five (5) sessions intended for new users and nine (9) sessions for returning users that discuss FY2023 Updates.

#### Applications for 2022-2023 Perkins Rural Reserve Grants Now Open

Applications for the <u>Montana Perkins Secondary Rural Reserve Grant</u> can be submitted for the 2022-2023 grant cycle. The purpose of this year's <u>Montana Perkins Secondary Rural Reserve</u> grant is to create career awareness, recruit, and retain students within a CTE Secondary Program of Study that leads to a high skill, high wage, or in-demand occupations.

There are currently 176 schools offering over 260 Career and Technical Education courses to students in grades 5-8 in our Montana schools. The most offered course is in career exploration. Since Montana does not receive enough funding to allow us to provide Perkins funding for middle school programs this year's Rural Reserve Grant will be to encourage pathway work for the middle grades.

Schools could use the funds to help:

- --establish innovative delivery methods for career exploration
- --expose students to employability skills earlier
- --establish foundational elements for work-based learning
- --improve transitions from middle grades into secondary Career and Technical Education pathways.

<u>Grants</u> of up to \$5,000 each will be available to secondary Perkins eligible school districts to support CTE work in the middle grades (5-8). Schools will have had to complete the Perkins Comprehensive Local Needs Assessment (CLNA), and their E-Grant application must be approved for the 2022-2023 Grant cycle before applying.

Schools that were awarded in previous years are eligible to apply, however, preference will be given to new applicants. The 2022-2023 application can be downloaded from the <u>CTE page</u> of the OPI website under the Funding menu.

# Public Service Loan Forgiveness Program

As an employee of a local public school system, you may qualify for the <u>Public Service Loan Forgiveness</u> (<u>PSLF</u>) <u>Program</u>. PSLF is a federal program that forgives the remaining balance on direct loans after 120 qualifying monthly payments under a qualifying repayment plan while an individual is working full-time for a qualifying employer.

Last year, the U.S. Department of Education announced a time-limited waiver to allow borrowers to receive credit for past periods of repayment that would otherwise not qualify for loan forgiveness. Under the temporary waiver, any prior period of repayment counts as a qualifying payment, regardless of loan program, repayment plan, or whether the payment was made in full or on time, provided the employment requirements are satisfied.

The waiver is only available for a limited time. The deadline to submit the <u>PSLF Application</u> for the waiver is October 31, 2022. Individual employees are responsible for submitting all necessary forms to the U.S. Department of Education. Requests for employment certification should be directed to campus human resources.

# Fun Facts & Trivia

*Bambi* is the life story of a fawn who grows up, with friends Thumper, the rabbit, and Flower, the skunk, to be the Great Prince of the Forest.

MGM filmmaker Sidney Franklin purchased the screen rights to the *Bambi* novel in 1933, but soon realized a live-action film with an all-animal cast would be too challenging to achieve.

Believing that only the artistry of Disney animation could fully bring this gentle story to life, Franklin contacted Walt in 1935 to encourage him to make the film instead.

Bambi premiered in London on August 9, 1942 and was released in the U.S. on August 13, 1942.

The animated feature film was based on the novel *Bambi: A Life in the Woods* by Austrian writer Felix Salten, the pen name of Siegmund Salzmann.

The voice of Bambi was provided by four different artists to mimic changes in voice as a boy grows to adulthood.

The film had been put into production as work on Snow White and the Seven Dwarfs was winding down.

The story of Bambi was different from anything else Disney Studios had ever attempted as it was more serious, and all the characters were animals.

In striving for realism, the artists heard lectures from animal experts, made field trips to the Los Angeles Zoo, watched specially filmed nature footage shot in the forests of Maine, and even studied the movements of two fawns that were donated to the Studio.

The work was meticulous; even taking care to see that the spots on the fawn's back remained constant meant fewer drawings could be finished in a day.

*Bambi* was released at a difficult time, with the United States deep in World War II, so its initial profits were low, but the story of the little deer coming of age has endured, and today, *Bambi* is universally regarded as one of Walt Disney's most charming films.

The film received Academy Award nominations for Best Sound, Best Song for "Love Is a Song", and Best Scoring of a Dramatic or Comedy.

Long before the direct-to-video production, *Bambi II* (2006), a sequel based on Felix Salten's second book, *Bambi's Children*, was actually in development after the release of the original film, but ultimately it was never produced.

*Bambi's Children* became a Disney comic book (Four Color #30, October 1943) drawn by Ken Hultgren and featured the Prince's fawns, Geno and Gurri.

In 1944, Walt Disney permitted the USDA Forest Service to use Bambi and his woodland friends in a forest-fire prevention campaign pre-dating their famous Smokey Bear character.

Bambi could not be used in the following campaigns because Bambi had been loaned for only one year, so the Forest Service needed to find an animal that would be the property of the Cooperative Forest Fire Prevention Campaign, leading to the creation of Smokey Bear.

In 2006 and again in 2010, Walt Disney's little deer returned to appear in new "Protect Our Forest Friends" anti-wildfire Forest Service campaigns.

In 2011, the Library of Congress added *Bambi* to the National Film Registry to be preserved as a cultural, artistic, and historical treasure.
