## **Tis the Season to Check and Verify TEAMS Data**

The Office of Public Instruction's <u>Terms of Employment, Accreditation, and Master Schedule</u> (TEAMS) system closed for data entry on Tuesday, November 1. Data reported in TEAMS includes all courses being taught for the 2022-2023 school year, number students enrolled, and the length of extended contracts, if offered.

For Career & Technical Education programs, TEAMS data is used to determine State CTE/VoEd funding allocations, for Perkins Grant data reporting, and Montana Career Pathways. Therefore, it is imperative the CTE data schools report is complete and correct.

Now is the time to check the data in TEAMS to be sure all your courses are listed, are aligned to the correct course code, and the correct student enrollment is listed. Any and all updates must be completed by December 1. Updates to TEAMS data can be submitted to Accreditation Data Specialist Ellery Bresler at ellery.bresler@mt.gov.

# Montana State CTE/VoEd Funding Allocations for 2022-2023 Now Posted

The State CTE/VoEd funding final allocations for the 2022-2023 school year are posted; the funds were released to schools on November 1. The State CTE/VoEd funding final allocations are generated based on the data entered in TEAMS (Terms of Employment, Accreditation, and Master Schedule) for the prior 2022-2023 school year.

The State CTE/VoEd funding final allocations include funds for student enrollment within CTE program area courses and funds for having an active Career & Technical Student Organization CTSO.

The CTE tab in TEAMS was made available last March and districts were asked to complete a few additional items on the tab and review the details carefully to make sure the data was accurate.

## **Applications for 2022-2023 Perkins Rural Reserve Grants Due December 1**

Applications for the <u>Montana Perkins Secondary Rural Reserve Grant</u> can be submitted for the 2022-2023 grant cycle. The purpose of this year's <u>Montana Perkins Secondary Rural Reserve</u> grant is to create career awareness, recruit, and retain students within a CTE Secondary Program of Study that leads to a high skill, high wage, or in-demand occupations.

There are currently 176 schools offering over 260 Career and Technical Education courses to students in grades 5-8 in our Montana schools. The most offered course is in career exploration. Since Montana does not receive enough funding to allow us to provide Perkins funding for middle school programs this year's Rural Reserve Grant will be to encourage pathway work for the middle grades.

Schools could use the funds to help:

- --establish innovative delivery methods for career exploration
- --expose students to employability skills earlier
- --establish foundational elements for work-based learning
- --improve transitions from middle grades into secondary Career and Technical Education pathways.

<u>Grants</u> of up to \$5,000 each will be available to secondary Perkins eligible school districts to support CTE work in the middle grades (5-8). Schools will have had to complete the Perkins Comprehensive Local Needs Assessment (CLNA), and their E-Grant application must be approved for the 2022-2023 Grant cycle before applying.

Schools that were awarded in previous years are eligible to apply, however, preference will be given to new applicants. The 2022-2023 application can be downloaded from the <a href="CTE page">CTE page</a> of the OPI website under the Funding menu.

## Fun Facts & Trivia

In the late 1860s on a ranch in Texas, a big, mongrel yellow dog befriends the Coates family, and in particular the two boys, Travis and Arliss.

The dog, Old Yeller, proves his loyalty by saving Arliss from a huge bear, Travis from wild pigs, and Mrs. Coates from a wolf infected with hydrophobia.

Old Yeller was a Christmas day release on December 25, 1957.

Old Yeller is based on the well-known book by Fred Gipson.

The film grossed over \$8 million in its initial release and has proved a perennial Disney favorite.

The movie stars Dorothy McGuire (Katie Coates), Fess Parker (Jim Coates), Tommy Kirk (Travis), Kevin Corcoran (Arliss).

Fess Parker also played Davey Crockett in Disney movies *Davey Crockett, King of the Wild Frontier* (1955) and *Davey Crockett and the River Pirates* (1956).

Both Tommy Kirk and Kevin Corcoran would go on to star in Disney movies *The Shaggy Dog* (1959) and *The Swiss Family Robinson* (1960).

The dog who played Old Yeller was named Spike.

In the movie a real golden Lab was used, but in the book the dog was described as a black-mouthed cur, which is similar but less bulky.

The 'wolf' was actually a German shepherd made up to look like a wolf and both dogs were taught how to play-fight.

During these bouts, both dogs were muzzled to avoid any accidental damage.

It was common for Disney to recycle sounds to cut down on costs, so you can hear the same growling sounds made by Old Yeller in *Lady and the Tramp*.

While set in Texas, the movie was filmed in California with the trick being finding areas that looked similar to what might be found in Texas.

Two educational films were made from the film, Love and Duty: Which Comes First? (1975) and an episode in the Films as Literature series.

A program on the Disneyland television series, The Best Doggoned Dog in the World, aired shortly before the film's release to promote the film.

*Old Yeller* was also featured in an episode of *Friends* when Phoebe's world view is shattered when she learns how *Old Yeller* really ends.

The episode, "The One Where Old Yeller Dies," aired April 4, 1996, as episode 20 of season 2.
